This <u>is</u> a base fee. Please note this <u>is not</u> a wait list fee.

<p>Non-Base Fees</p>	<ul style="list-style-type: none"> • Overtime rate of \$10.00/hour will apply for care after 6pm or care over 10 hours per day. This is a non-base fee. • Reduced Daily Rate of \$12.00/day/child will be charged when back-up care is offered & not used. This is a non-base fee. • Non-Sufficient Fund Transfer (NSF) fees; 1st/\$50.00, 2nd/\$75.00, 3rd/\$100.00, further incidents will result in a review of account & possible termination of care. These fees are non-base fees.
