<h3>Registration Process</h3>	<ul style="list-style-type: none"> <li>• To ensure Wee Watch optimizes your childcare needs, with initial contact parents are asked: age of child(ren) requiring care, preferred area or location, start date of childcare, and type of care – full-time or part-time</li> <li>• We will ask you to complete our <a href="#">online application</a> (hard copy available upon request)</li> <li>• Registration Fee \$21.26, due upon receipt of your Application. This <b><i>is</i></b> a base fee and is non-refundable. Please note this <b><i>is not</i></b> a wait list fee.</li> <li>• To secure a childcare space a monthly payment is required at orientation and outlined in your Welcome Letter. This <b><i>is</i></b> a base fee and is non-refundable.</li> <li>• A Security Deposit will be collected at orientation that will be applied to the final 2 weeks of care, outlined in your Welcome Letter. This <b><i>is</i></b> a base fee and is non-refundable.</li> <li>• Please see Agency Specific Financial and Administrative Policies, available upon request and will be provided at registration.</li> </ul>	
<h3>Base Fees</h3>	<h4>Full Time Weekly</h4> <p>(Up to 10 hours a day of care)</p>	<h4>Part-Time Days (2-4 days/week)</h4> <p><b>If available</b> Please consult the office, minimums apply</p>
<h4>Infants/Toddlers /Preschoolers</h4> <p>(0-4 years)</p>	<p>\$110.00/week</p>	<p>\$22.00/day</p>
<h4>Kindergarten</h4> <p>(4-5 years old)</p>	<p>\$87.40/week</p>	<p>\$18.43/day</p>

<b>Non-Base Fees</b>	<ul style="list-style-type: none"> <li>• A late fee of \$10/hour prorated to the minute, will be charged for all late pick-ups after 6pm or over 10 hours of care per day. This <u>is</u> a non-base fee and non-refundable.</li> <li>• Reduced Daily Rate of \$12.00/day/child under 6yrs, will be charged when back-up care is offered &amp; not used. This <u>is</u> a non-base fee and non-refundable.</li> <li>• Non-Sufficient Fund Transfer (NSF) fees; 1<sup>st</sup>/\$50.00, 2<sup>nd</sup>/\$75.00, 3<sup>rd</sup>/\$100.00, NSF's may (at agency discretion) be accepted as 2 weeks notice of ending care and your Security Deposit will be applied, as per Agency Specific Financial and Administrative Policies, available upon request, see Welcome Letter for details.
